The Prison Phoenix Trust CIO (PPT) – Treasurer Job Description

The Treasurer of The Prison Phoenix Trust, in addition to their Trustee role, has specific responsibilities.

Overall

The Treasurer's role is to monitor the financial administration of the charity and report to the Board of Trustees at regular intervals on its state of financial health, in line with best practice, and in compliance with the governing document and legal requirements.

Responsibilities and duties

- Overseeing and presenting budgets, internal management accounts and annual financial statements to the Board of Trustees, and making sure that they understand what the accounts are saying;
- Leading in the Board's duty to ensure that proper accounting records are kept, financial resources are properly controlled, invested and economically spent, in line with good governance, legal and regulatory requirements;
- Overseeing the production of The PPT's Annual Report and Accounts;
- Leading in the development and implementation of financial reserves, cost-management and investment policies;
- Liaising with The PPT's Finance Manager, who is responsible for the day-to-day financial activities of the charity;
- Monitoring and advising on the financial viability of the charity;
- Overseeing the implementation of and monitoring specific financial controls and adherence to systems;
- Advising on the financial implications of the charity's strategic plan, and presenting an annual budget to the Board;
- Overseeing the charity's financial risk-management process;
- Acting as a counter signatory on charity cheques and important applications to funders;
- Liaising with the external auditors or independent examiners.

Skills/qualifications required

- A professional accountancy qualification (ICAEW or equivalent);
- Proven ability to communicate and explain financial information to members of the Board;
- Analytical and evaluation skills, demonstrating good judgement;
- Good communication and leadership skills;
- Commitment to the aims and principles of The Prison Phoenix Trust;

Desirable

- Experience in charity finance;
- Working and/or living within easy access of The PPT's offices in Oxford

Time Commitment

The PPT employs a Finance Manager who is responsible for day to day financial management of the charity. The Treasurer's involvement usually revolves around the quarterly Trustees meetings. In practice this means:

- Spending several hours in the weeks before each meeting to ensure that a comprehensive financial report is presented;
- Attending two or three meetings with the Director and Finance Manager towards the end of the year to facilitate the production of a budget for the year ahead;
- Occasional meetings or correspondence with the Finance Manager to consult on specific issues;
- Attending the office in person where necessary to act as a counter signatory;
- A day's work reviewing the draft Annual Report and Accounts prior to their submission to the external auditors.
